## I. INTRODUCTION

María Jesús Pablos, after twenty-five years of service as the Executive Director of the Commission, retired at the end of 2011. The Spanish Government honored her with the *Encomienda de la Orden de Isabel La Católica* (Decoration of the Order of Queen Isabella the Catholic).



The Commission is pleased to welcome Alberto López San Miguel as the new Executive Director, effective January, 2012. A former Fulbright graduate student at the Fletcher School of Law and Diplomacy, Tufts University, he brings to the binational Commission management experience in both the private and public sectors as well as a keen interest in international education.

Shortly after the change, the Commission was informed by the Ministry of Education, Culture and Sports that its offices would be moved to the street address calle General Oráa, 55, from Paseo del General Martínez Campos, 24, home to the U.S.-Spain Fulbright Program for twenty-one years. The move took place in September 2012.

### **PROGRAM DEVELOPMENT**

In times of public funding shortages, the Commission, with the special support of the U.S. Embassy, is seeking private sector sponsorship. The campaign strategy for additional financial backing has been carefully outlined and is now in the initial phase of required procedural action.

#### *U.S. Program*

Exchange activity in the U.S. Program has remained constant in the graduate student and scholar categories. There were, however, a considerable number - the maximum allowed - of Fulbright Senior Specialists visiting Spain. This program has generated much interest since its initiation, and the Commission greatly regrets its suspension for the coming year, as it responded extremely well to needs for short-term experts in fields across the board.

#### *Spanish Program*

During the current year, the number of grants awarded has remained altogether steady. However, as a result of severe budget cuts in Spain, affecting all sectors but in particular education, the Commission is anticipating a reduction in Spanish grant awards during the upcoming year(s).

### *Spanish Postdoctoral Research Program*

This year, the Commission, together with the Ministry of Education, Culture and Sports has added a new subcategory within the visiting scholar program, which was initiated in 1981-82. On the U.S. side, Senior Lecturers and Researchers have long been an integral part of the Exchange, whereas this opportunity for Spaniards has been virtually non-existent.

The Commission greatly welcomes this initiative that will afford senior Spanish scholars the possibility to research and teach for three to six months in the U.S.

### *U.S. English Teaching Assistants*

A comparatively cost-effective program, it continues to be robust as the regions of Madrid and Cantabria seek to improve language skills and are turning to place emphasis on "American" English within the secondary school sector. The program has grown in Cantabria during the reporting year through the Botín Foundation. The public/private sector arrangement ideally exemplifies dedication to the betterment of English language skills and bilingual education in this area of Spain.

A new initiative this year has been to renew a limited number of ETAs in both Madrid and Cantabria. The objective is to improve organization, training and support in English teaching and in the Global Classrooms Program.

The Regional Government of Valencia curtailed its TA program, not only with the Fulbright Commission but other sponsors as well, due to shortage of funding.

### *Global Classrooms: Model UN*

The Fulbright Commission has for the first year operated as the program fiscal agent on behalf of the local sponsors: Regional Government of Madrid (Office of Education), the U.S. Embassy, and the British Council/Madrid. Cooperation with the Global Classrooms Program began in 2005-06 when it was first introduced in the Madrid public school system, through the active and steadfast Fulbright English Teaching Assistants. Each succeeding year has marked an improvement in the organization, development, and implementation of the program. The Model UN/Global Classrooms Program would not have achieved the success that can be claimed today without the strong financial support from the U.S. Embassy in Madrid of the Model UN Conference in New York City and its active local input, the hands-on management by the Madrid Office of Education (*Consejería de Educación*), Regional Government of Madrid (*Comunidad de Madrid*), the grant from the Better World Fund/UNA-USA to cover partial local costs, and the highly generous and effective participation of Fulbright grantees.

## ***Outreach***

### *Spanish Fulbright Alumni Association*

Ties between the Commission and the Association, founded in 1990, have been noticeably strengthened since January. The Commission has vigorously encouraged Association participation in traditional events such as arrival orientation for U.S. grantees and pre-departure orientation for outgoing Spaniards; continued sponsorship of "tertulias" (intellectual gatherings) with guest speakers to discuss philosophical, historical, political, artistic and other themes; social get-togethers (lunches/dinners); and, concerts by U.S. grantees and former Spanish Fulbrighters.

### *Fulbright/APUNE/Carlos III University*

In May, the Commission and the Association of North American Universities in Spain (APUNE) celebrated the first Meeting of U.S. and Spanish Universities in Spain. The objective was to review and evaluate the current status of U.S.-Spain exchange between students, scholars and university administrative personnel. Hosted by the Carlos III University-Madrid, a leader in the internationalization of higher education in Spain, the meeting addressed the situation in the three university sectors. As the first event of this type, it was enhanced by the presence of the U.S. Ambassador, Alan D. Solomont, as the inaugural guest speaker. Presiding were the University Rector; the Director General of University Policy, Ministry of Education, Culture and Sports; the Executive Director, Fulbright Commission; the Vice Rector of International Relations; and the President of APUNE. The meeting included some thirty vice rectors of international relations as well as representatives of the CRUE (Conference of Rectors of Spanish Universities).

## PROFESSIONAL VISITS AND TRAVEL

The U.S. Assistant Secretary for Education and Cultural Affairs, Ann Stock, visited the Commission in March. It was a great pleasure to observe firsthand her detailed interest and attention to the Program in Spain. The Educational Adviser described involvement in EducationUSA, and five current U.S. and former Spanish grantees gave brief presentations on their experiences as Fulbright students and scholars.

During the period January – May, the Executive Director visited Washington for introduction to the Department of State and CIES, and subsequently New York to familiarize himself with the IIE; Vienna to attend a Fulbright European Executive Director Meeting; and Dublin for the annual meeting of the European Association of International Educators.

The Executive and Deputy Directors traveled to Valladolid, Santander, Navarra, and Barcelona in a public relations effort to promote interest in Fulbright exchange at both the postgraduate university and primary/secondary school levels.



## **NEW WEB PAGE**

After the overcoming some difficulties in developing the new website and management program, the Commission was finally able to launch the new website in January 2012. This new site is a more dynamic and user friendly web source for the public, and it incorporates a management program with a powerful database, which is very important for the work carried out by the Commission.

## **SOCIAL/PROFESSIONAL MEDIA**

Since January, the Commission has highlighted Fulbright activities and news through the social media and strives to: give greater recognition to the name of Fulbright in Spain, broaden dissemination of grant programs, stimulate the interest of sponsors, and create new channels of communication with grantees and ex-grantees.

The framework of communication contents can best be summarized as: grant calls for U.S. and Spanish citizens; Commission activities such as interviewing applicants, pre-departure and arrival orientation sessions, mid-year evaluation meetings as well as news, special events and activities pertaining to or organized by grantees and alumni.

## **ACKNOWLEDGEMENTS**

The Commission is especially grateful this year to the J. William Fulbright Foreign Scholarship Board for its singular review of FSB procedure to expedite grant approval and consequently the issuance of visa documents. As always, it furthermore thanks the Bureau of Educational and Cultural Affairs (ECA) of the U.S. Department of State; EducationUSA for continuing, additional financial support; the Ministry of Foreign Affairs and Cooperation; and, as in past years and in particular, the Ministry of Education, Culture and Sports for continued support of Commission activities.

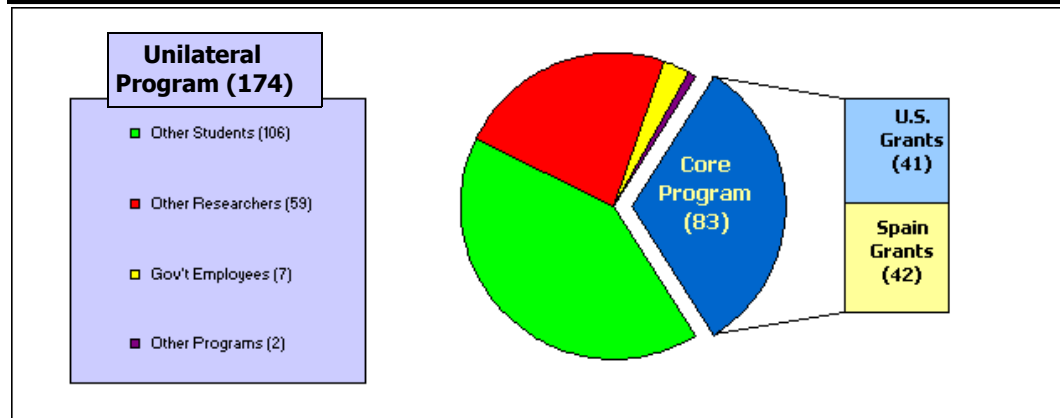

## ***PROGRAM PLAN AND ANNUAL REPORT COMPARISON***

For academic year (AY) 2011-2012, the projected figures in the annual budget proposal of November 2010 were underestimated by eleven (11) awards when compared to September 2012 actual figures. The most notable variations in projected numbers are explained below.

### ***U.S. Program***

The U.S. Program has seen some growth mainly thanks to the increased number of strong and suitable project requests for Senior Specialists from host institutions in Spain. After a decrease in previous years, the maximum number of six (6) grants was reinstated. This, together with an increase from two (2) to four (4) postgraduate grants in collaboration with the IE Business School, offset the slightly lower numbers in the Senior Lecturers and Madrid Regional Government Teaching Assistantships programs.

Additionally, a new grant category sponsored by the IIE / Mellon Foundation has been launched and two (2) graduate students received awards.

### ***Spanish Program***

Overall, the Spanish Program has grown by four (4) awards. There was a significant variation in projecting grant numbers for the Ministry of Education, Culture and Sports visiting researchers program. Twenty-seven (27) renewals, which were not originally accounted for in November 2010, have been included. A ministerial delay in publishing the grant announcement resulted in the FY2009 grantees reporting to their institutions in September 2010, instead during AY2009-2010 with renewals scheduled for AY2010-2011.

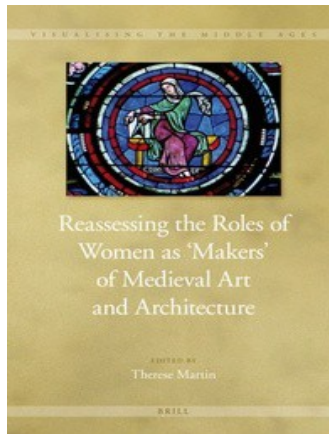
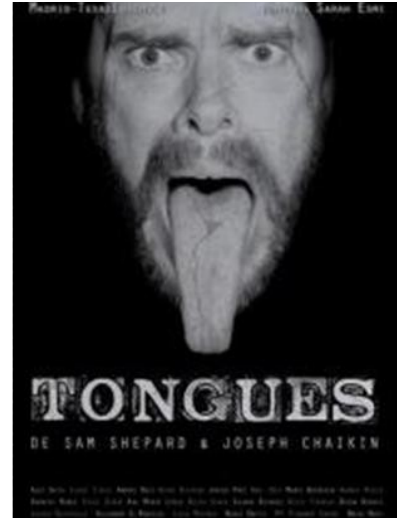
Due to budgetary limitations and last-minute candidate withdrawals, there were also slight program reductions in the following grant categories: core graduate students; Foreign Language Teaching Assistants (FLTA); Ministry of Education, Culture & Sports students; and the Ministry of Industry, Energy and Tourism programs.

Lastly, the summer 2012 grant program for underrepresented populations was temporarily suspended by the Department of State. It is expected that the program will be re-launched for summer 2013.

## II. GRANTEE AND ALUMNI ACCOMPLISHMENTS

### U.S. PROGRAM

*Sarah Esmi*, 2011 English Teaching Assistant in Madrid, directed the *Madrid-Texas Ensemble* in Sam Shepard's theater play *Tongues*. This adaptation of *Tongues* not only explores the auditory nature of the piece, but also pays close attention to the visual.



*Therese Martin*, 1997 Graduate Student in Madrid, and a scholar in Art History, published the book *Reassessing the Roles of Women as "Makers" of Medieval Art and Architecture*, where she proposes a renewed way of framing the debate around the history of medieval art and architecture to highlight the multiple roles played by women.

*Libby Masback*, 2011 English Teaching Assistant in Cantabria, organized the "Cine Migratorio" (*Migratory cinema*) film festival, in conjunction with the non-profit organization "Cantabria Acoge." The goal was to show the migratory phenomenon through real stories told in first person by those who lived them.



*Haroula Rose Spyropoulos*, 2005 English Teaching Assistant in Madrid, is releasing her second full album, *Here The Blue River*. Besides, she is co-writing - including original music - and performing in a short film called *No Love Song*.



*Anna Tonna-Brown*, 2007 Graduate Student in Madrid and mezzosoprano, recorded a CD based on her research in Spain about the vocal repertoire of Spanish composers from the early 20th century.

*Azareen Van der Vliet Oloomi*, 2010 Graduate Student in Gerona, released her new book, *Fra Keeler*, a fiction about a house that has received high reviews such as "...the work of a terrific young writer!" and "...A rare gem of a book that begs to be read again."



## ***Community Involvement***

Many U.S. grantees devoted part of their time in Spain to volunteer work and community involvement initiatives such as:

*Jacalyn Bedara* and *Hannah Connor* gave English lessons to children from immigrant families through the "Asociación Barró".



*Joshua Brown* cooperated with "Fundación Secretariado Gitano", a non-profit organization that fights discrimination towards the gypsy community in Seville.

*Ana Chamberlain* had an internship with DARA, an international think tank, where she worked on a project called the Climate Vulnerability Monitor. DARA does research and evaluation on the effectiveness of international humanitarian response.

*Max Deardorff* took part in the "Jornadas de Reforestación Participativa", an initiative of the Universidad Pablo de Olavide and the Universidad de Sevilla, aimed to recover forest areas destroyed by fire by planting trees.

*Kathleen Griesbach* fostered an abandoned dog named John, through the non-profit organization "Animales Con Un Nuevo Rumbo" (*Animals with a New Direction.*)

*Elisabeth Masback* collaborated with "Cantabria Acoge", an organization centered in facilitating the integration of immigrants.

*Alexandra Pons* joined a local environmental non-profit organization and applied what she learned there to her classes as a TA, becoming her school *guru* on environmental issues.

*Laura Portko* started the Cantabria chapter of *Sunday Soup*, a system of independent micro-grants, where money goes directly to a proposal without having to be mediated by the bureaucracy of a granting organization.

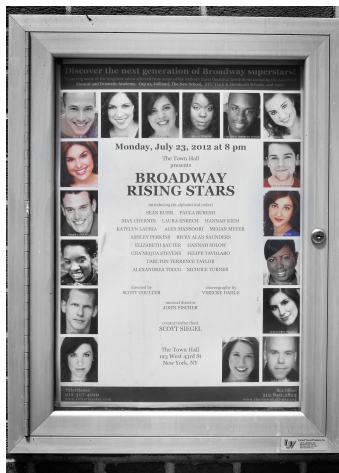

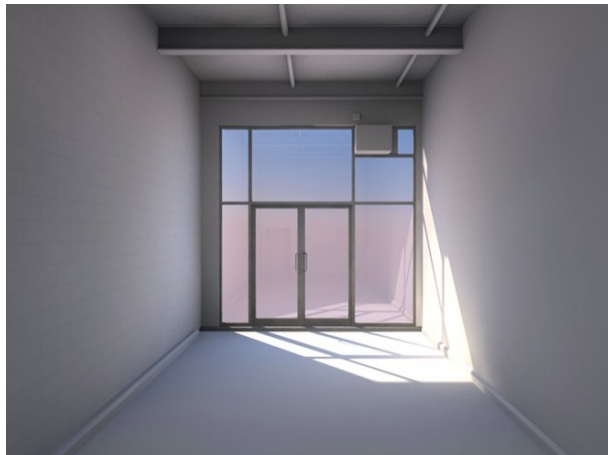
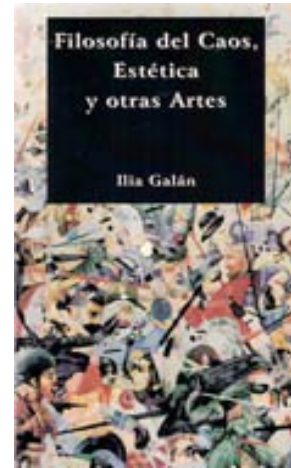

*Raul Gomez Valverde*, 2009 Fulbright student in Photography, School of the Visual Arts, presented his show *2010-2030* at Ventana244 Art Space (New York) which included a single piece entitled *As an artist, I look for this kind of drama*. The work is a computer-generated simulation of the gallery, lit according to the solar trajectory of March 12, 2030; the day the artist turns 50 and achieves "his fulfillment as an artist." From 2010 to 2030, he will develop a series of videos displaying how sunlight affects exhibition spaces —from sunrise to sunset —, on that specific date. Since the artist expects to live 100 years, the chosen day coincides also with the midpoint of his life.

*Miguel Guitart Vilches*, 2001 Fulbright student in Architecture, Harvard University has announced his project for the new Santa Maria Church and Parish Center in Bonavista, Tarragona. The project will become an architectural, urban and social beacon taking as a starting point two premises recurrent in the Catholic Church: monumentality and mystery. Construction works started in summer2012.

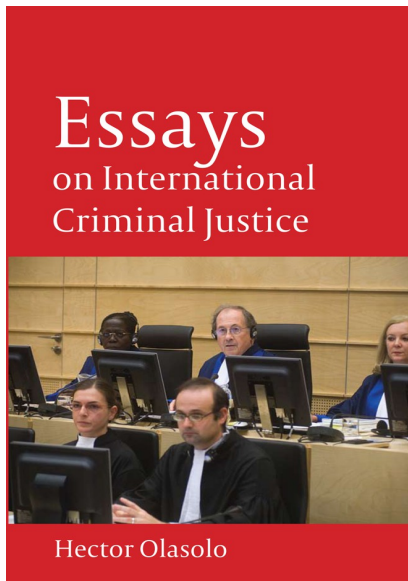

She curated [Region 0](#) - the Latino Festival of Video Art New York, at the King Juan Carlos I Center of NYU. She is also the executive director of the project [Round Trip NY](#) and contributor to the online publication XTRART, a portal specialized in cultural promotion and reflection. Currently she is working on an exhibition featuring works by Latin American and Spanish artists at the Art Museum of the Americas in Washington, DC.

*Jorge Muriel Mencía*, 1999 Fulbright/Ministry of Culture student in Theater Arts, Herbert Berghof Studio translated and performed in the play "*El proyecto Laramie*". The show debuted in New York in 2000 and the Spanish version premiered in the Teatro Español this past year. The work is based on real events that occurred in Laramie, Wyoming where Matthew Shepard, a 20-year old student, was brutally beaten and killed by two local adolescents because of his homosexuality. The case received wide media attention and the victim became a major symbol for increased social tolerance.

Dr. Olasolo is currently a professor at Utrecht University and Chairman of the Ibero-American Institute of the Hague for Peace, Human Rights and International Justice.

*Jose Vicente Siles Perez*, 2010 Fulbright/Ministry of Education research scholar in Telecommunications Engineering, NASA Jet Propulsion Laboratory won the 2012 NASA/JPL Outstanding Postdoctoral Research Award in the Technology, Instrumentation, and Engineering category. This prestigious recognition is given annually to most the distinguished scholar chosen from a pool of more than 110 postdoctoral researchers.

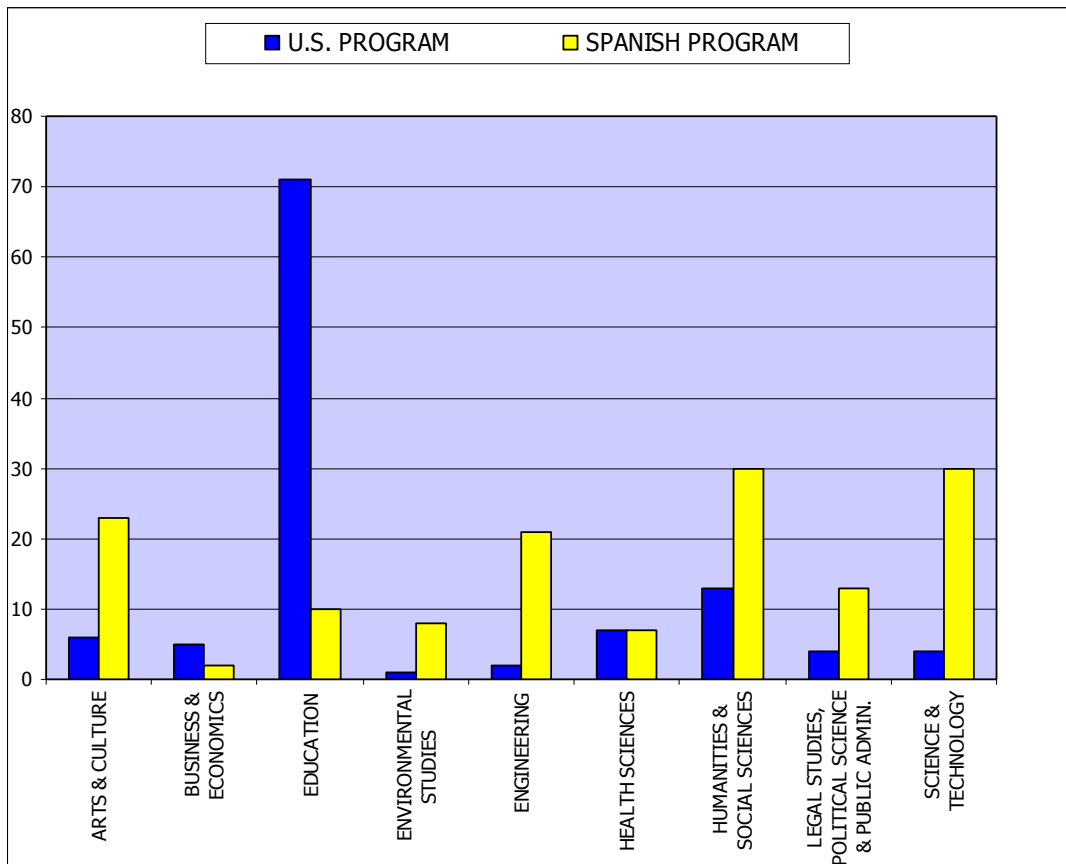

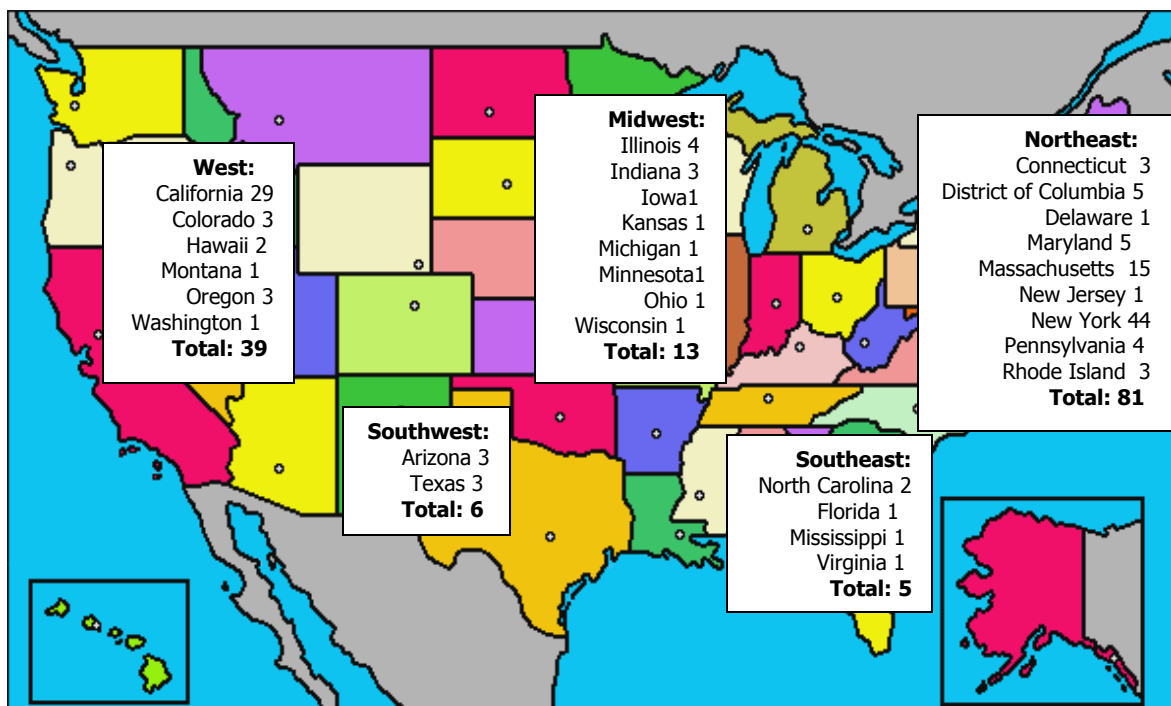


#### IV. GEOGRAPHIC DISTRIBUTION

## **V. NON-GRANT ACTIVITIES**

### ***EUROPEAN REGIONAL ACTIVITIES FOR U. S. GRANTEES***

As in previous years, interest in both the Berlin and E.U. Seminars was very high. There were two representatives from Spain at the E.U. Seminar, cofinanced by this Commission, including the Fulbright-Schuman (U.S.-E.U.) grantee in Barcelona. Six grantees from Spain attended the Berlin Seminar, including one performer invited by the German Commission and one Teaching Assistant sponsored by this Commission. They both had an active role in the seminar activities.

Five Intercountry Lecturers in Italy (2), Finland, Austria and the Czech Republic came to Spain invited by universities in Madrid (2), Barcelona, Valencia and Granada, and one Senior Researcher in Spain was invited by the University of Genoa.

### ***EUROPEAN REGIONAL ACTIVITIES – SPANISH PROGRAM***

At the request of the Belgian-Luxembourg Commission, Fulbright-Schuman applicants residing in Spain were interviewed and prescreened by Commission staff. The program, administered in Brussels, is jointly financed by the U.S. Department of State and the Directorate-General for Education and Culture of the European Commission. The program offers awards for research/postgraduate study; grants to professionals in international education administration; or awards for lecturing at U.S. universities. All grants are limited to projects dealing with U.S.-E.U. relations or E.U. affairs. For academic year 2011-2012, one (1) International Educator from Spain was selected to carry out research in the International Office of Arcadia University (PA) while promoting European higher education.

The Executive Director continued to sit on the Andorra Fulbright Bilateral Committee as a Permanent Observer. The Commission sustained its collaboration by interviewing Andorran applicants and including U.S. grantees to Andorra and Andorran grantees in activities organized by the Commission (i.e. participation in the U.S. orientation program; mid-year meetings for U.S. grantees; and, pre-departure orientation and visa processing for departing Andorran grantees).

### ***GRANT ENHANCEMENT***

#### ***U.S. Program***

##### ***Mid-Year Seminar for U.S. Grantees in Spain and Andorra, Academic Year 2011-2012***

The *Universidad de Valladolid* hosted this year's spring seminar from February 22 to 25, 2012. The working sessions – both for all participants and for smaller groups - and cultural activities were partaken by 101 grantees; accompanying family also enjoyed the latter. Representatives from the Commission, the Regional Government of Madrid, the *Universidad de Valladolid*, and the Valladolid major joined the opening ceremony and other activities. The working sessions in small groups were a success thanks to the collaboration of the many former Spanish grantees who led them. The evaluation reports were very positive and proved that the seminar was a highlight for the U.S. grantees.

*Madrid Global Classrooms and the Model U.N. Conference in New York, Academic Year 2011-12*

Ten public schools participated during the 2011-12 school year with involvement of up to 20 high school teachers, 220 students (9<sup>th</sup> grade equivalent), 14 current Fulbrighters, and several former grantees highly interested in the Program. For next year (2013) the number of participating schools will be increased to 18.

Participation in the Madrid Global Classrooms fosters a series of attitudes and values which enriches participating 3<sup>rd</sup> level of ESO students from some of Madrid's Bilingual Public High Schools and prepares them to be responsible agents in a complex and interdependent world. Global Classrooms teaches students the specific decorum and procedures applied in UN events, as well as the social skills required to propose, negotiate and build consensus around proposed courses of action. It also requires critical thinking and media literacy in the research phases, public speaking skills to debate persuasively, and writing skills to draft well-argued and fact-supported position papers.

### Project "Comparte tu mirada"

Through the English Teaching Assistant Program, the Commission enthusiastically agreed to support a voluntary youth project promoted by the Regional Government of Madrid. The project aimed to sensitize high school students to community problems and to seek their solutions, on a voluntary basis, by means of practical exercises.

A total of eight Fulbright grantees worked on the project. With the help of English teachers from their schools, they organized groups of students whose main task was to take photographs of their school community, highlighting and identifying social problems. This project offered a special opportunity for an extracurricular, English reinforcing activity to those schools not involved in the Global Classrooms Program.

The participating schools presented their top photos at an exhibition in the *Nuevos Ministerios* metro station. The Ambassador of the United States to Spain attended the exhibition inauguration, speaking with students and teachers about their work.

### *Orientation for U.S. grantees in Spain and Andorra, Academic Year 2012-2013*

A total of 89 U.S. student grantees going to Spain (84 out of 89) and Andorra (5 of 5) attended the four days long meeting held at the *Instituto Internacional en España* in Madrid from September 10-13, 2012. Collaborators from the US Embassy, the Ministry of Foreign Affairs, the Regional Government of Madrid and the Government of Andorra participated in the opening ceremony and also in the working sessions, some of them led by former grantees – both from Spain and the U.S. - that generously donated their time and experience. An ESL specialist sponsored by the U.S. Embassy and the Regional Government of Madrid provided invaluable training for the incoming Teaching Assistants.

### ***Spanish Program***

Grant enhancement activities still remain a priority and lead to an augmented Commission public reputation vis-a-vis competing educational exchange programs that noticeably do not provide these supplementary events. Activities, especially designed for Fulbright candidates, are provided throughout the award period - before departure; upon arrival in the U.S.; during the grant period; and as alumni. The overall effect increases public visibility for the Fulbright Program and portrays the binational institution as a public-oriented service entity.

Pre-departure orientation and group visa processing sessions were offered for graduate students and postdoctoral researchers. These sessions offered special opportunities to bring together individuals from various grant categories and backgrounds to form a cohesive group with common interests. Activities included staff presentations and discussions on grant administration topics and clarifying visa regulations. Alumni panels shared personal, professional and academic experiences with departing grantees.

The U.S. Embassy in Madrid continued to be especially helpful in issuing visas. For the past nine (9) years, group sessions specifically for departing Commission grantees have been arranged to facilitate visa processing and required personal interviews. This special consideration expedites the issuance of visas and, once again, provides a positive awareness of Commission support services.



The graduate student session included fifty-four (54) participants representing seven (7) grant categories and sponsorship from three (3) Regional Governments; three (3) Ministries; two (2) foundations; one (1) private institution as well one (1) public U.S. university. The U.S. Ambassador hosted a grantee luncheon at the official residence and attendance included Commission Board members and sponsors. The Andorran Commission was represented by an official from their Ministry of Education, Youth and Sports, and one student grantee - accompanied by a family dependent - also participated in the day-long pre-departure orientation program which included a group visa processing session.

For the postdoctoral researchers' pre-departure orientation, twenty-nine (29) grantees and four (4) accompanying dependents participated. The session was held in the Commission and included visa processing at the U.S. Embassy. The Commission Board member and Deputy Director for Professor Training and Exchange of the Ministry of Education and the Executive Director welcomed the group. Two (2) other Ministry officials joined Commission staff in discussing grant administration topics.

The Board Secretary of *El Corte Inglés*, a major department store chain and sponsor for the past 25 years of the Fulbright/CEOE Foundation program for journalists, offered a luncheon for the newly selected candidate and program alumni. The event enabled the Commission to acknowledge this generous and loyal sponsorship as well as provide a venue for returning grantees to reunite.

The Commission also engaged Spanish alumni in reviewing applications, interviewing candidates for Fulbright awards and as speakers and panelists for special events. Through the Commission's webpage and social media, alumni have multiple opportunities to be informed and involved in the Commission's activities.

Grantees in the U.S. were also able to enjoy enrichment activities provided by collaborating agencies. The Commission is grateful for the funding provided by the U.S. Department of State for pre-academic training and Gateway Orientation programs. In summer 2012, thirty-three (33) graduate students and fourteen (14) Foreign Language Teaching Assistants (FLTAs) attended these programs. A number of students and FLTAs also participated in regional Enrichment Seminars organized by IIE. Likewise, visiting scholars benefited from the professional and personal enrichment activities organized by CIES, the U.S. Fulbright Association and the National Council for International Visitors.

## **ACADEMIC INFORMATION SERVICE**

### **EDUCATIONAL ADVISING**

#### **Statistics**

The Educational Advising Center met its outreach objectives for 2011-12, with 504 outreach/mobile advising contacts; more than 300,000 unique website hits; a growing social media following; and stable phone/e-mail/group advising contacts. As more Spanish students join the digital trend, the Educational Advising Center has adapted its approach to reach a wider audience on a more frequent basis. The separation of EducationUSA and Fulbright Spain social media networks and the launch of a more complete and dynamic website, including a database for advising contacts, have made the sharing of information on Fulbright grants and US study more effective while also facilitating follow-up.

#### **Outreach/Mobile Advising**

The Center is particularly pleased to note that the number of contacts reached through outreach/mobile advising grew 57% year-on-year. Advising staff participated in a total of fourteen events in FY11-12, reaching just over 500 advisees. In addition to attending fairs, holding public information sessions at Spanish universities and high schools, new initiatives included talks to US study abroad students in Madrid and a counselor training on "Helping Your Students Apply to US Universities." The adviser hopes to continue offering an ongoing series of training seminars for secondary school professionals interested in learning more about US undergraduate education. The Center is grateful to the International College Spain for donating space for this event, as well as

to Syracuse and American Universities for their support and to the College Board for sending a speaker to liaise with the counselors.

Traditional contacts (e-mail advising, phone advising and group information sessions held at the Fulbright Commission) remained stable.

### ***Outlook***

ECA's continued support for additional staffing has been instrumental in allowing this growth to happen. The Center expects this trend to continue in FY2012-13 thanks to funding already received for events during International Education Week, a Grad School Seminar and travel throughout Spain and support staff for the Educational Advising Center.

The Adviser also benefitted from attending the EducationUSA Forum in Washington, DC, where she made valuable contacts. Many US university representatives from all levels of US education (community colleges, undergraduate admissions, LLM programs) are presenting at EducationUSA-sponsored events this fall as a result.

### ***Support for International Educational Exchange***

The Commission continues to show its support for International Educational Exchange by offering office space to organizations that are actively promoting US-Spain educational exchange, like the Assist scholarship program for outstanding Spanish secondary school students and the Association of North American Programs in Spain (APUNE). In fact, the Fulbright Commission and EducationUSA partnered with APUNE to



organize the First Annual Meeting of Spanish and American Universities and the Educational Adviser spoke at two re-entry workshops for US study abroad students on post-graduate study opportunities in Spain.
